Cancellation, if unavoidable, should be made via phone to the KFM Market Manager, Patricia, at (817) 875-2360, no later than 8:00 a.m. the Friday prior to the scheduled performance.

Insurance and Indemnity

All authorized buskers participating in the Keller Farmers Market (KFM) shall be individually and severally responsible to KFM and the City of Keller (the City) for any loss, personal injury, deaths, and/or any other damage that may occur as a result of the busker's negligence or that of its servants, agents, and employees. All buskers hereby agree to indemnify and save KFM and the City harmless from any loss, cost, damages, and other expenses, including attorney's fees, suffered or incurred by KFM and the City by reasons of the busker's negligence or that of its servants, agents and employees; provided that the buskers shall not be responsible nor required to indemnify KFM and the City for negligence of KFM and the City, its directors, volunteers, servants, agents or employees. No insurance is provided by KFM to participants in KFM.

I have read the Busker Application 2012 and the KFM Rules & Regulations 2012. If accepted into KFM, I hereby agree to abide by said Rules & Regulations. I acknowledge full responsibility for all my activities in the market, and for those assisting me, throughout this season's market, May 5 - October 27, 2012. I acknowledge the authority of the KFM Market Manager, Executive Director and the KFM Board of Directors to immediately settle any disputes regarding presentation, demonstration or entertainment legitimacy, procedural and conduct violations, and impose any penalties, including possible suspension or removal from the market.
